### 1. ROLL CALL @ 10am - McPhail

  - o 52 attendees, 43 club Present

#### 2. STATE OF THE UNION – McPhail

- USA Updates Congress / Need for elections
  - i. Sharpley 16 reps, 2 from each GU
  - ii. McPhail How will the election process be determined?
  - iii. Sharpley No idea, a process will be proposed by the ad-hoc committee
  - iv. McPhail My recommendation would be to have one rep the President (or someone from the Board) and another representative from the GU. We need to determine from now till the Fall AGM to determine how we choose our reps.
- GU Updates continuing to grow but don't know purpose
  - i. McPhail As you know we have been a pilot GU from the start, there have been a large number of other GUs submitted for approval to USAR. The 7 LAUs that were included in the West have been broken up and redefined with other/new GUs.
  - ii. Can you clarify the difference between the GU/CRs?
  - iii. McPhail GUs were created to remove a layer of management from USA Rugby. SBROs & Collegiate Conferences were encouraged to break out and be independent. Their only reporting body is USA Rugby. Now that the CRs have been introduced it has caused somewhat of a struggle to determine who is determining competitions/structure etc.
  - iv. Sharpley The CRs competitions committee is entirely Board driven (USAR). It has also been determined that Competition will be Nationally run. This mandate was given by CEO Nigel Melville that all Competitions will be Nationally run.
  - v.Courtney Had a followup question, but we tabled for later in the agenda.
  - vi. McPhail The GU/CR landscape is very dynamic and ever changing. We need to be flexible and open to change...
- Collegiate Updates Changes with in Colleges and addition of LSC Women
  - McPhail 5 Collegiate Conferences for 2013-2014 Competitive Season. 3 Men's Club and 1 Club Women's Division. HS is still pending, but could have two Conferences.
- High School Updates Match Fees, Field Policy, On going discipline
  - McPhail HS will pay mileage this year. Also, mileage was upped to \$0.35/mile (for all divisions).

### 3. REVIEW OF COMPETITION RESULTS – McPhail

- General summary USA @ Dallas; TRU @ Galveston
- Mens Results:
  - o TRU D2 / D3: Griffins; Austin D1B
    - McPhail Austin Blacks D1b won TRU D3 Championships and advanced. D2, Frisco Griffins advanced.
  - West: D1 Teams: Austin, Harlequins, Dallas Reds, Huns (order of finish)
    - Austin Blacks and Dallas Harlequins advanced to Playoffs.
  - USA Playoffs @ Dallas
    - Austin RC, Dallas Harlequins, Griffins, Austin RC D1B
      - Dallas Reds held the USA Rugby Playoffs and did a great job! (Clapping)
- Collegiate Results: SWC, ARC, LSC and SWWC
  - SWC Rice advanced; Issues with hosting and pathways
    - Rice traveled to Wisconsin and faced Bowling Green, lost 94-17. From that experience and others, the SWC have decided they will play within Texas and not go for a National Championship through USA Rugby.
    - Anderson Will that affect the Eligibility of those Collegiate players? Would they be eligible for Club play?
    - Courtney No, I don't believe so.
    - Sharpley They can apply for a waiver, but only if they are a graduating a Senior.
    - McPhail We will follow up with USA Rugby in regards to that question.
  - Lonestar Robertson: The LSC competes under the NSCRO and follows their eligibility guidelines.
     We had 2 teams advance to a Playoff with Colorado, our teams didn't do so well and discovered that the level of play is high. The CO teams advanced to the NSCRO Playoffs.
  - o SWWC
    - Schmidtke For 7s we held 3 7s Tournaments and Texas placed fourth at USA Collegiate 7s; A&M did well at 15s and advanced to the Round of 8.
  - $\circ$  SWC
    - Butch A&M won the ARC and declined the option to explore a USA Rugby Championship.
  - o LSWC
    - Roberson We have seven women's teams included, new programs but excited about the number of teams.
- High School: Texas Only (STT and ???)
  - Wolfinger D1: St Thomas won RT Championships over Westlake, Lake Travis won in D2.
- Discipline Matters: Referee Abuse by Coaches / Players; Failure to adhere to Sideline / Barrier Policy
  - o McPhail We need compliance for the Sideline/Barrier Policy. It has been on the website since 2010.

- Courtney From a Disciplinary Chair stance, sideline/barriers help with disciplinary. We are looking
  for the top level clubs, we are looking for you to be exemplary in these policies. You are the example
  for all of the other clubs.
- Watson One of my main objectives is to ensure that your fields are setup correctly. If this is not done correctly, we do give out fines. Please review all of the Operating Policies so you are in compliance. Random visits will be given by TRU Board Members and if you are not in compliance, you will be fined. Lastly, Coaches/Subs, you DO NOT have "conversations" with the referees during the match, if so, sanctions will be served. There is no wiggle room for referee abuse.
- McPhail Running commentary is also not acceptable, if your coach acts this way, the players will act that way. It is a trickle down effect from the Coach to the players, spectators and fans. Note that there is a <u>Participation Agreement</u> on the TRU website that is required of all clubs, make sure you review it and sign it.
- Sharpley Is the system of fines documented anywhere on the web site?
- o McPhail Yes, it should be included in the Operating Procedures.
- Schmidtke The Referee Abuse extends to ARs that are helping the Center Referees. You cannot
  have a running dialogue with the AR, the only acceptable conversation is subbing.
- Courtney Coming this Fall, we will be offering a FREE online TJ course for teams. The idea is that
  if teams have certified TJs it can help raise the level of the match. More details will be coming on this
  soon.
- Sharpley Is there a requirement that clubs have a certain number of certified TJs?
- McPhail It was discussed at the time, but we were not able to get the program off the ground,
   originally it was a partnership with USAR. We tried to implement it last season, but USAR was not a good partner in that endeavor.
- Courtney Yes, there is a requirement, but since the program wasn't implemented, we couldn't
  enforce it at the time.

  - $\circ$  D1 = New Orleans?
  - O D2 = Little Rock, Tulsa
  - O D3 = Midland (needs 2012 resolution)
  - O Women D1 = Oklahoma Roses & Tulsa
